Notes to List of Acceptable Verifying Documents:

- 1. The collection of identity information is governed by the National Identification and Registration Act, 2021 (the Act).
- 2. The National Identification and Registration Act, 2021 outlines the list of identity information that is required and/or that may be used to enrol in the National Identification System (NIDS). The required set of identity information will vary from person to person as it is determined by the person's particular circumstances.
- 3. It may be necessary to collect personal information (personal data) that does not fall within the category of identity information to effect the enrolment in the NIDS, for example for, a) administrative purposes such as contact information to be able to communicate with persons, or b) information relating to persons with disabilities where those persons wish to have such information displayed on their National Identification Cards.
- 4. All identity information must be verified, that is they must be checked for truth and accuracy against certain source documents before being accepted. These source documents are known as verifying documents.
- 5. This List sets out different verifying documents that are required under the Act and that are the most common and most useful. The Authority may also accept other documents where necessary.
- 6. A person will not be required to submit more than one verifying document to prove more than one piece of identity information but must submit the documents stated under the Act where there are alternatives.
